With the help of more than 250 dedicated volunteers in 2022 dedicating 5,323 hours, we rescued 310,000 pounds (1.4 million healthy servings) of produce and organic farm proteins, efficiently re-distributing it to neighbors in need, and keeping it out of landfills.

We continue to partner with several other nonprofit organizations to further identify and alleviate hunger and its associated poor nutrition throughout the region. We have increased our nutrition and culinary education outreach program significantly to teach healthy eating for life to thousands of recipients. We remain committed to keeping surplus healthy food out of landfills and diverting it to our neighbors in need.
